Terms & Conditions for Independent Agents of Dash (UK) Ltd and Hooked on Stationery

Hooked on Stationery is operated by Dash (UK) Ltd ("Dash," "we," "us," and "our"). Please read these Terms and Conditions carefully before using the Hooked on Stationery websites, which are www.hookedonstationery.com and www.hookedonstationery.co.uk.

By using the Hooked on Stationery websites, you agree to be bound by this Agreement. If you do not agree to the terms and conditions of this Agreement, please do not use the Hooked on Stationery Websites. Further, by using the Hooked on Stationery Websites, you affirm that you are of legal age to enter into this Agreement (18 years or older) or, if you are not, that you have obtained parental or guardian consent to enter into this Agreement. If you are not of legal age to enter into this Agreement and have not obtained parental or guardian consent to enter into this Agreement, then you may not use the Hooked on Stationery Websites.

We reserve the right to change this Agreement, in whole or in part, from time to time at our sole discretion, and to provide you with notice of such change by any reasonable means, including without limitation by posting the revised draft of this Agreement on the Hooked on Stationery Websites. Your continued use of the Hooked on Stationery Websites following the posting of changes to this Agreement will mean that you accept those changes.

Upon completion of the Independent Agents Application Form we will inform you of your appointment as an Independent Trader with access to the Agents pages on the websites. The minimum order amount for orders is £20 excluding carriage.

Your status as an Independent Trader with access to the Agent pages of the website will be continuous if there is at least 1 Trader purchase within the first 14 days of your application, then ongoing in any consecutive 3-month period. Following a period of Trader inactivity of more than 3 consecutive months, Agents membership and ID could be removed without notification.

As an Independent Agent for Dash (UK) Ltd and Hooked on Stationery, you are a self-employed contractor and will therefore be personally liable for taxes and/or duties as required by UK law which include income tax and national insurance contributions, both of which require proper records of Trader activity to be kept. If you are registered for VAT, you must keep proper records and accounts as required by HMRC, notify us of your registration detail and ensure accurate collection and payment of VAT duties.

Dash (UK) Ltd and Hooked on Stationery Agents will have no geographical limitations within the United Kingdom for selling products. Independent Agents must not, without prior written permission from the Directors of Dash, which will not unnecessarily be withheld, sell any of the company's products to third parties or retail outlets. Independent Agents must not sell or advertise products for less than the Dash recommended retail price.

Dash (UK) Ltd reserve the right to terminate your appointment within the first 30 days following the issue of your Independent Agents ID. This termination notice will be in writing or by email from one of the company directors detailing the reason for termination.
